Grant from Matilda daughter of Richard Carpum de Weryngton to Doms Richard, chaplain, fil Henry fil Ralph de Weryngton of an acre of land in Weryngton, lying in the Holey near the land of Richard del Bouche at Childebrugge, for the use of Adam his son and his heirs on the body of Agnes de Wygan (procreated). For default to Richard son of Allis de Billinton and his heirs; for default to Godyt sister of the said Adam and her heirs. Remainder to the said Matilda. Witnesses, Adam de Hybernia, John le Norrayes, John de Holland, Roger Culchyt, and Henry, clerk. No date.
- S.D. Grant from William fil Simon de Gerstan to Henry de la Bruche of one third of a Burgage and an acre of land in Weryngton, lying between land of Pernell widow of Gilbert Cisoris in the Kirk-stret. Witnesses, Alan de Rixton, Henry Fabaro de Weryngton, Nicholas Beton, William Lamb, and John fil Dyot. No date. W. 2.
- s.d. Grant from William le Botiler son of Amaurice le Botiler de Weryngton to John son of Diote de Weryngton and to his heirs of three acres of land in Weryngton, lying in Orford between the land of William de Thurlew and

that of Thomas Austen, to be held by homage and service and a rent of 8^d yearly. Witnesses, Roger de Sonky, Robert fil Nicholas de Samelisbur, and William, clerk. No date. W. 3.

- S.D. Grant from Roger de Sonky to William his son and heir of all his land, meadow, and water in the territory of Weryngton together with the manor of Sonky, &c. Witnesses, Henry Tyldisleye, William de Kenion, Jordan de Kenion, Robert de Samilsbrow, Hugh de Penkeyt, Henry de Penkeyt, and Henry de Kenion. No date. Seal, green wax, oval, a fleur de lys, circumscribed "Rogeri de Sonk." W. 4.
- S.D. Confirmation of the above grant by Roger de Sonky to his son William de Sonky. Witnesses, Henry de Tildeslegh, seneschal of Weryngton, Robert de Samnullesbyr, Hugh de Penchock, Henry of the same, Jordan de Kenyan, William de Kenyan, William de Eccles, and Robert de Wetefeld, clerk. Grant from Robert fil Robert de Glasebrok to William de Holercroft of the messuage and land at "les Holyns" once held by Richard de Holyn, lying between the land of William de Beusie on one side and the "mere diche" on the other, with certain lands abutting on the king's way and certain headlands on the water of the Mersey. Witnesses, William de Athirton, Alan de Rixton, Henry Travers, Robert de Wolston, and Gilbert Culchyte. No date. Seal, remains of one of red wax, bearing a bird.

- Release from William le Botiller, lord of Weryngton to William fil Roger de Sonkey de Weryngton of those lands which D'ns William le Botiller his grandfather (avus meus) held of the said William de Sonkey for the life of the said lord William the grandfather by serjeanty and "hawardia" in Weryngton. Witnesses, Mathew de Haydoc, Gilbert de Fochewre (?), Gilbert his son, Alan de Rixton and Alan his son, Richard de Moston and William his son, and Robert de Sonkey. Dated at Weryngton, Sunday after the Translation of S. Thomas the Martyr, 28 Edward I.
- 1300. Grant and release from William le Botiller, lord of Weryngton to Alan de Rixton his heirs and his tenants within the fee of Werington that he shall have but one beadle instead of two, &c. Also that they should be free of Bodee and Wytchenes, also of stallage and "flortol." (See p. 121 Beamont's Lords of Warrington.) - 1330. Bond for the declaration of a debt of 32 pounds in silver, due from Richard del Legh, Henry de Molyneux, Ralph de Halsnade and John de Gerstan to John de Denum. If any of the debtors die before the sum is paid John de Denum is at liberty to seize the bodies of Thomas son of John de Molyneux and Richard son of Hugh del Legh of Torbeley and lodge them in Lancaster goal until the debt is discharged. (In old French.) Dated Monday after S. Hillary, 4 Edward III. W. 17.
- 1334. Grant from Agnes daughter of Thomas del Heath de Werington, in pure virginity, to Jordan son of Henry Fabre of a moiety of a burgage in Werington and of an acre of land in Holay with land in the Townfields over against "le Dunselathe." Witnesses, Richard fil Henry, William Lembe, William de la Forde, William Schedde and Robt Dim chaplain. Dated, Sunday, S. Gregory the Pope, 9 Edward III. Seal, green-brown wax, round. on a fess between two fish, three mullets, and an ornamental border round the seal. W. 18.
- 1344. Grant from Robert de Moston son of Richard de Moston to William de Moston, junior, of the rents and services of Richard de Bruche, of Richard de More, of John de Heepay, of Henry son of Thomas for the lands they hold of the same Robert in Wolston. Also the rents and services of Richard Wilkynsone de Fernihed, of Richard le Beene de Erburie, of Robert Wilkynsone of

Fernyhed, of Robert de Wolston de Fernyhed, of Gilbert de Sotheworth, of Cecil son of Robert del Wod, of Robert Lethwyne, of William del Wod, and of Agnes de Egge for the premises they hold of the same Robert in Wolston. - 1362. Statute merchant for 4 marks in silver from John fil Adam de Weryngton to John de Wadington, clerk. Dated at Weryngton, Tuesday, S. Peter "in Cathedra," 36 Edward III. W. 27.
- 1363. Grant from John fil Adam de Werington to John de Wadyngton, chaplain, of his lands in Werington, as security for 4 marks of silver. Dated Wednesday, S. Michael the Archangel, 37 Edward III. W. 28.
- 1363. Release from John de Wadyngton, clerk, to Hugh de Laycet de Weryngton and Margaret his wife of the lands mortgaged to him by John fil Adam de Weryngton, in consideration of the repayment of the 4 marks lent to John fil Adam. Witnesses, Peter le Smyth, Robert de Weryngton. Dated Wednesday after All Saints, 37 Edward III. W. 29.
- 1363. Grant from John fil Adam de Weryngton to Hugh Leycet de Weryngton and Margaret his wife of all his lands, &c., in Weryngton. Witnesses, Peter le Smyth, Thomas fil William fil Robert le Boaster, and Robert del Forde. Dated Monday after S. Wilfrid, Bishop, 37 Edward III. W. 30.

- 1385. Demise from Sir John Botiller of Weryngton Knt to Nicholas de Rixton and Isabella widow of Mathew de Rixton of six messuages with gardens and land in Weryngton. The messuages lying severally in "le Newgate," "Bonstrete," "Hechstrete," "Baggelane," and near "Bryche-mylne," for the lives of Nicholas and Isabella, the rent one rose yearly. Demise from Sir John le Botiler Kn^t to Sir John de Pulle Kn^t, Peter de Dutton, Peter de Legh and Richard le Massy de Rixton of the Tolls of the town of Weryngton for five years at two pepper corns rent, and after at 100^{lb} of silver with power to re-enter if the 100^{lb} be in arrear. Dated at Bewsey, Thursday before the Conversion of S. Paul, 18 Richard II. Seal, red, a covered cup within a shaped oval.

1427. The will of Richard Werburton, naming his wife Elizabeth, his brother William Werburton, also Hamon and William Massy and others. Leaves £10 for two years to the Parish Church of Budworth, for prayers for his soul, &c. Dated 27th December, 1427. Administration granted the executors—Elizabeth Werburton the relict, and Hamon and William Massy—26th June following. Remains of brown seal, an ecclesiastic [?] holding a cup. W. 44

1435. Grant from William Troutbek Esqr, Robert del Mere, Richard Bolde, John Hawardyne, and William Holme, chaplain, to William le Mascy son of Hamon le Mascy of Rixton of all the messuages, &c., in the county of Chester which they had of the feoffment of the said William le Mascy. Witnesses, Ralph Maynwaring, Hugh de Dutton, and Robert le Grosvenor. Dated at Hertford, 21st March, 13 Henry VI. Three seals remain; two bear designs only; the other red, in a circle an owl, with P'RUS on one side and LE MELER on the other.
